Please make checks payable to The Dayton Foundation, Inc., and note the account name or number on the check's memo line. You also can contribute online by using a credit card or by electronically transferring funds from a personal savings or checking account. Both options are easy to use, secure and available through Donor Express on our web site by clicking on the Contribute to Your Account button in the left menu.

Once your initial contribution has been received, you may begin to direct grants to charities within three to five business days.

If your organization ceases to exist, any remaining balance in your organization's account will go to The Dayton Foundation's Emerging Community Needs Fund for the Foundation to use where community need is greatest (unless arrangements are made for a named endowment fund.)
