



Together We Thrive: Del Mar Grants for Older Adults

FY2027 Request for Proposals

Due Dates: Friday, November 6, 2026, and Friday, April 9, 2027, by 4:00 p.m.

Together We Thrive: Del Mar Grants for Older Adults, offered by The Dayton Foundation, are awarded to 501(c)(3) tax-exempt nonprofit organizations that focus on addressing the needs of older adults in Greater Dayton. The organizations we consider for support are located primarily in Montgomery, Miami, Greene and Preble counties. The size and number of grant awards are directly related to the amount of money available. Decisions will be made at the discretion of The Dayton Foundation's Grants Committee, based upon the assessment of any criteria it finds to be relevant.

To be eligible for a grant, your organization must:

- be recognized as a 501(c)(3) tax-exempt nonprofit organization, according to the Internal Revenue Code;
- be established for at least two years as a nonprofit organization and have a track record of sustainability;
- provide direct assistance to older adults in the Dayton Region;
- demonstrate systemic collaboration with other human needs service providers; and
- demonstrate a commitment to creating opportunities and access for all individuals in organizational practices.

What We Look for in a Project

- Comprehensive program design
- Realistic expectations and the capacity to implement the project
- Appropriately trained staff and/or volunteers
- Financial resources to start and continue the project
- Unique and unduplicated opportunity that will affect a substantial number of people
- Size and potential impact

What We Generally Do Not Fund

- Private foundations
- Projects that are narrowly focused in geography, impact and number of participants
- Individuals
- Annual fundraising drives, ceremonies, conferences and workshops
- Public or private schools
- Endowment funds

- Scientific, medical or academic research projects
- Sectarian activities of religious organizations
- Scholarships and travel grants
- Cultural arts productions
- Economic development projects
- Hospitals and universities
- Publications, including books, reports and/or research papers

Together We Thrive: Del Mar Grants for Older Adults

Together We Thrive: Del Mar Grants for Older Adults, or Thrive Grants, are quick grants for local nonprofit organizations serving adults ages 60 and older in Greater Dayton. The grants assist time-sensitive programming and projects.

- Grants are designed to fund qualified grant requests from \$5,000 up to \$20,000.
- The size and number of grant awards are directly related to the amount of money available each year.
- Organizations with open Thrive Grants are not eligible to apply for a new grant until the final report has been submitted and the grant has been closed. In addition, if an organization’s final report is past due and no attempt has been made by the organization to extend the final report deadline, the organization will become ineligible to apply for a grant from the Foundation for a period of two years after the report has been submitted.

FY2027 Application Deadlines

All Thrive Grants applications are due by 4:00 p.m. on the deadline date.

How to Apply for a Grant and Proposal Outline

Use the RFP Form (page 5) and the following outline to present your proposal. Make sure to answer all of the questions completely, but limit the narrative (numbers 2-3) to no more than three pages. *For the RFP Form and Signature Page, use the forms provided. Do not include these introductory pages (1-4).*

1. RFP Form (page 5)
2. Project/Program questions
 - a. Please briefly summarize your proposal including the following information:
 - i. an overview of your request;
 - ii. how it will work/how the need will be addressed;
 - iii. who it will serve;
 - iv. who is involved in your project (partnerships and collaborations);
 - v. how exactly will the requested funds be spent; and
 - vi. a timetable for implementation of the project.
3. Overview of your organization, including the mission/purpose
4. Funding and support (sample provided, page 6)
 - a. An itemized project budget with revenue indicating if funding has been secured, is pending or potential and expenses
 - b. Financial sustainability: If this program/project will be ongoing, outline your plan to secure future funding. Use an additional page, if needed.
5. Attachments
 - a. A copy of your organization's most recently completed audit, including auditor's notes (If the organization does not have an audit, please submit the [Del Mar Audit Exemption Form](#).)
 - b. A balance sheet covering your organization's most recently completed fiscal year
 - c. An income statement covering your organization's most recently completed fiscal year
